  - 5.1 Report from CSULB President Jane Conoley: TIME CERTAIN 2:15 pm
    - 5.1.1 **DACA** re-ups are an on-going process. Helping with application fee.
    - 5.1.2 **Email security**—spike in compromised computers from phishing—288 compromises in Jan. alone. They're following up on those for whom this has happened 2-3 times. Check at <u>alert@csulb.edu</u> for questions about suspicious emails.
    - 5.1.3 Working on increasing gender-inclusive restrooms-
      - 5.1.3.1 Apel reports: Seeking input from campus community now as they are expensive modifications. If you have strong feelings email Scot Apel. The first site would to get such would be the Student Union.
      - 5.1.3.2 J. Doering says they're discussing this same issue at ASI.
    - 5.1.4 **Follow up on murdered student**, Estephan Hernandez--\$10K reward now offered. Clearance rate for murders is 9% in the community where the student was murdered.
    - 5.1.5 **Question: not enough counselors on campus** especially in light of school shootings. VP Taylor: True. But hired two new from student health fee recently.

- 5.1.6 Question: Crosswalk between Nursing and SCS dangerous not well marked. Apel asked by Pres. to work on crosswalk issue.
- 5.1.7 **Commencement venue:** Pres.: Celebrating decision to reinstate live music at commencement. Sorry I focused on money issues and not other issues. There was a communication lapse on graduation ceremony—we didn't share the problem first we were trying to solve

- 5.2 Report from CFA President Doug Domingo-Forasté—.ppt presentation.
  - 5.2.1 **Janus v. ASCME**: Origin of term Right-to-work [RTW] was from a white supremacist. After the Supreme Court decides Janus, expect that people will come to you to drop your union membership when. CFA expecting that the Supreme Court will make us a RTW country. Salary increases negotiated by union amount to 16.5% in recent years. Need your union dues of 1.35% on gross to talk with legislators about the CSU, do issue research, etc. CFA has prevented takebacks of benefits and defended faculty rights.
