5 **POLICY ON THE RIGHTS AND PRIVILEGES**
6 **OF EMERITUS FACULTY**

7 (This policy supersedes Policy Statement 13-01.)

8
9 This policy statement was approved by the Academic Senate on 10/19/2017
10 and approved by the President on 12/7/17.

12 **1.0 Emeritus Faculty**

13
14 In recognition of their contributions to the University, all faculty, including lecturers, upon
15 retirement from California State University, Long Beach with 10 years or more of full-
16 time equivalent service are awarded "Emeritus" status at their highest academic rank at
17 retirement. Breaks in service do not disqualify a lecturer from attaining Emeritus status.
18 The President, acting upon the recommendation of the appropriate department, college,
19 or equivalent unit, may also grant Emeritus status to retired faculty, including lecturers.

21 **2.0 Rights of Emeritus Faculty**

22
23 An Emeritus faculty member *shall*:

- 24
25 2.1 Receive an Emeritus Faculty Identification Card entitling them to the usual
26 attendant privileges.
27 2.2 Receive a letter of congratulations from the President of the University.
28 2.3 Be listed in the university catalog.
29 2.4 Be granted a university-provided e-mail account and access to the wireless
30 network on campus.
31 2.5 Be eligible for standard university discounts for College of the Arts and University
32 Athletics public events.
33 2.6 Be eligible for full faculty library privileges.
34 2.7 Be eligible for free faculty parking.

35
36 **3.0 Privileges That May Be Extended To Emeritus Faculty**

37
38 An Emeritus faculty member *may*:

- 39
40 3.1 Be invited to participate in departmental, college, and university social functions.
41 3.2 Be eligible to serve as a thesis committee member, in accordance with University
42 and department policy.

43
44 **4.0 Special Privileges That May Be Extended To Emeritus Faculty**

45 *Under certain circumstances* Emeritus faculty *may*:

- 47 4.1 Be eligible to participate in sponsored research projects subject to appropriate
48 university approval.
- 49 4.2 Use office space, if available, and approved by the department chair and the
50 college dean. Office space provided to Emeritus faculty must be renewed
51 annually by the department chair and the college dean.
- 52 4.3 Use laboratory space and equipment, if available, for university-sponsored
53 research activity when approved by two-thirds of the tenured/tenure-track faculty
54 of the relevant department(s), with the approval of department chair(s) and the
55 college dean(s).

56
57 **5.0 University Compliance**

58
59 Additionally, Emeritus faculty using university offices, laboratory space, and equipment
60 must be appointed as official campus volunteers by their dean. All campus rules,
61 regulations, and limitations that apply to faculty also apply to Emeritus faculty using
62 offices, laboratory space, and equipment.
