**Additional Information**

It is the student's responsibility to adhere to all prerequisites listed below. It should be noted that several prerequisites fulfill general education requirements.

1. A grade of "C" or better in FMD 253, FCSE 296, and CHEM 100 (fulfills G.E. Category B1b) or CHEM 111A (fulfills G.E. Category B1b) are prerequisites for FMD 353.
2. A grade of "C" or better in ECON 100 and 101 (each ECON course mentioned fulfills G.E. Category D2), FMD 355, and senior standing, for FMD 457.
3. A grade of "C" or better in FMD 353 and FCSE 296, senior standing, only open to Textiles and Clothing majors (FCS\_BA05); open to Fashion Merchandising and Design majors (FCS\_BA04) by permit only are prerequisites for FMD 458.
4. Completion of GE Foundation courses, and a grade of "C" or better in ANTH 120 or SOC 100 or 142 (each ANTH and SOC course listed fulfills G.E. Category D2) and upper division standing are prerequisites for FMD 450 (fulfills G.E. Category D2 and Global Issues).
5. A grade of "C" or better in FMD 351 is the prerequisite for FMD 451.
6. A grade of "C" or better in FMD 451, 455, or 457 is a prerequisite for FMD 492E (refer to '11-'12 CSULB *Catalog* for additional prerequisite requirements for FMD 492E).
7. The minor in Textiles is available to any non-Fashion Merchandising and Design or any non-Textiles and Clothing major.
