Accepted proposals will be announced by the Ukleja Center for Ethical Leadership in April 2024. Selected stipend recipients shall submit their research to a minimum of one (1) peer review journal with documentation provided to the Ukleja Center for Ethical Leadership by May 1, 2027. In addition, stipend recipients shall submit a 500-word summary of their research to the Ukleja Center for Ethical Leadership by May 1, 2027. Ethics research stipend recipients will also give a brief presentation of their research at a Ukleja Center for Ethical Leadership event. Selected ethics research recipients will receive the first half of their award (\$2,500 less payroll taxes and other payroll deductions) by September 1, 2024 and the remaining balance (\$2,500 less payroll taxes and other payroll deductions) after completing the aforementioned deliverables by September 1, 2027.

FACULTY HISTORY OVER THE LAST THREE YEARS: On **no more than 3 separate pages**, provide complete citations of journal articles, book chapters, conference presentations, and other intellectual contributions produced during the period covering from July 2020 to June 2023. Acknowledge co-authors (if any) and indicate whether each intellectual contribution is refereed or non-refereed. In addition, list all current and pending internal and external support for your proposed project.
