## **New, Changes To, and Discontinuances of Programs**

- 1. Create a post-baccalaureate certificate in Communicative Disorders to be offered through CCPE. Recommended to the senate on October 7 2009.

#### **General Overview**

The council spent the majority of the academic year working on two areas of policy. The first, a new policy on "Timely Graduation of Undergraduate Students" was developed in response to the Chancellor's Office initiative to reduce the number of super-senior students. We attempted to balance the needs of high unit majors and students with a legitimate need for double majors with speeding students to graduation in a timely manner and thus maximizing access to CSULB for eligible students. This policy was approved unchanged by the senate on 9 March 2009. The majority of the year was devoted to developing a single policy dealing with all aspects of graduate degrees, a process that had begun in the 2008-09 academic year. The result was four proposals (numbers 4-7 above) to the academic senate. The council decided to separate out the policy on other post-baccalaureate degrees (#6) from that on masters degrees (#7).

#### **Unfinished Business**

Late in the year the council considered changes to the General Education policy recommended by GEGC. Most of these were approved with minor changes but the recommendation to remove the two lab science requirement from area B proved very contentious. After two meetings which included presentations by the interested parties the council was unable to reach consensus and decided to postpone a final decision to 2010-11. The senate returned the policy on multisection courses to the council pending the development of a policy on standard course outlines. It is expected that such a policy will be developed in Fall 2010.
